SEEDING: Bring your completed *Official Entry Form* (seeding sheets) [duplicate your own extra copies], pen or pencil and calculator to the seeding meeting at Parkland High School (Cafe, Athletic Complex) on **Sunday, February 5, 2006 – 1:00 p.m.** This is the final verification of entries and team point scorers. Anyone not making weight on Saturday, February 11, 2006, is scratched from the tournament. **NO WEIGHT CLASS CHANGES ARE ALLOWED AFTER SUNDAY’S SEEDING MEETING.**

* More than one entry per weight class is allowed with double elimination for all wrestlers.

ENTRANCE PASSES: Each team is allowed a maximum of five (5) entrance passes for coaches, trainers and managers.

AWARDS: Medals are awarded for 1st through 8th place.
A Team Champion Award, a Team Runner-Up Award, and a Team Third Place Award will be presented.

PICTURES: Pictures of tournament champions, team champion and team runner-up will be taken at the completion of the HWT final. Place winner pictures will also be taken after the completion of the final for each weight class. **You must be in uniform.**
